

Application for Open Air Burning and Incinerators Permit 2018 – 2020

To be eligible for a Permit to Burn, you must understand the fire danger ratings. Ratings are forecast using Bureau of Meteorology data for up to four days in advance, based on weather and other environmental conditions such as fuel load.

- You CANNOT burn during the fire danger period.
- Permits are only valid provided fire restrictions are not in force.



The categories below explain the types of Permits available.

Category A – EAST

If you own or reside on a property located east of Mullum Mullum Creek which is greater in size than 2500 square metres, you are eligible for a 3 year Permit to Burn, expiring on 30 November 2020.

- You CANNOT burn during the fire danger period.
- Outside of the Fire Danger Period, you cannot burn when the fire danger rating is very high or above. It is the Permit holder's responsibility to ensure they are aware of the fire danger rating for the day they intend to burn.
- You cannot burn on Sundays during June, July and August.
- You must register any burning off with ESTA (Emergency Services Telecommunications Authority) on 1800 668 511.

Category B - WEST

If you own or reside on a property located west of Mullum Mullum Creek which is greater in size than 2500 square metres, you are eligible for a 3 year Permit to Burn, expiring on 30 November 2020.

- You CANNOT burn during the fire danger period.
- Outside of the Fire Danger Period, you cannot burn when the fire danger rating is very high or above. It is the Permit holder's responsibility to ensure they are aware of the fire danger rating for the day they intend to burn.
- You cannot burn on any Sunday.
- You are only permitted to burn during the months of May, September and November.
- You must register any burning off with ESTA (Emergency Services Telecommunications Authority) on 1800 668 511

Category C – VACANT OR UNOCCUPIED LAND

If you own vacant or unoccupied land that is greater in size than 2500 square metres, you may be entitled to a Permit to Burn for specific dates during the year. This Permit will be valid until the declaration of the fire season or 30 November 2018.

- Your property will require an inspection by Council to determine if the burn can be undertaken safely.
- You will need to have your burn piles in a cleared location ready for inspection.
- You will need to have a sufficient water supply available on site in order to extinguish if necessary.

Upon receipt of your application, an assessment will be undertaken and a Council Officer will contact you within 10 working days.

Permit Conditions

Further conditions apply to all Permits and will be provided on approval of your Permit. You must read and be aware of any conditions prior to engaging in open air burning.
