5. Refunds and new registration fees apply as follows:

Date	Cancellation of Registration	New registration (includes Transfer of a food business)
< 1 April	50% closure refund	Full registration fee to 31 December
< 1 July	25% closure refund	Full registration fee to 31 December
> 1 July	\$0 refund	50% registration fee to 31 December
> 1 October	\$0 refund	Full registration fee (*up to 15 months registration applies)
