

# **FOGO Colouring Competition 2023**

# TERMS AND CONDITIONS OF ENTRY

- 1. The "FOGO Colouring Competition" (**Competition**) is being run and managed by Manningham Council, 699 Doncaster Road Doncaster Victoria 3108 (**Proponent**).
- 2. Entrance into the Competition is deemed as acceptance of these Terms and Conditions of Entry.
- 3. Failure by the Proponent to enforce any of its rights under these Terms and Conditions of Entry at any stage, does not constitute a waiver of those rights.
- 4. The Proponent may disqualify any entrant deemed to be not complying with the Terms and Conditions of Entry and the Entry Requirements at its sole discretion.
- 5. Entry to the Competition is achieved by returning to the Proponent during the Promotional Period:
  - a) the completed (coloured in) FOGO colouring image; and
  - b) the correctly completed entry form,

by pre-paid post (using the reply-paid portion included on the entry form), in accordance with the below Entry Requirements.

6. The Proponent may, at any time, at its sole discretion, modify these Terms and Conditions of Entry, including its Privacy Policy, with or without notice. Any such modification will be effective immediately upon the Proponent publishing revised versions of the Terms and Conditions of Entry and/or Privacy Policy (as the case may be) on the Proponent's website. Continued participation in the Competition following any such modification constitutes acceptance of the modified terms.



# PROMOTIONAL PERIOD

- 7. Entries must be received by the Proponent during the campaign period which opens from 9.00am (AEDT) on Monday 27 March 2023 and closes at 5.00pm (AEST) on Monday 8 May 2023 (**Promotional Period**).
- 8. Winners will be randomly drawn by the Proponent on Tuesday 16 May 2023 and contacted using the contact details provided on the winner's correctly completed entry form.
- 9. Winners will also be announced on the Proponent's website from Monday 22 May 2023.

#### WHO CAN ENTER

- 10. Individuals under the age of 18 must ensure they have permission from a parent and or legal guardian before submitting their entry.
- 11. The Proponent's staff, contractors and Councillors and the family members of any of these groups are not eligible for entry into the Competition.
- 12. Entrants in the Under 5 years of age and in the 6 to 12 years of age categories must be under the respective age limit at the time of submitting their entry.

# **ENTRY REQUIREMENTS**

- 13. Entry to the Competition is free.
- 14. There is a limit of one colouring image entry per person.
- 15. Entries can only be submitted in one age category.
- 16. Entries will not be returned to entrants.
- 17. All images are final at the time of submission of an entry. Entrants are unable to make edits to an image once an entry has been submitted.
- 18. Entries submitted as part of this competition may be displayed by the Proponent including online display including (without limitation) website, social media and broadcast media channels. Entries may be edited, amended and/or collated by the Proponent. As a condition of entering this Competition, entrants consent to having their entry (colouring image), first name, age and suburb of residence displayed by the Proponent and published in these ways, including on the Proponent's website.
- 19. By entering this Competition, all entrants:
  - a) consent to the Proponent using, editing or modifying their image to support the Proponent in promotional material at any time and without compensation;
  - b) warrant that entries submitted are an original work that does not infringe on the copyright, trademark, intellectual property or moral rights of any third party.



20. To enter, eligible entrants must submit their entry during the Promotional Period by providing their details in all fields on the entry form.

# WINNER DETERMINATION AND PRIZE INFORMATION

- 21. Images meeting the Entry Requirements will be eligible for winning. Two (2) entries will be randomly drawn by the Proponent in each of the 4 age categories as winners on Tuesday 16 May 2023.
- 22. Two winners per age category will be selected.
- 23. An entrant can only win one prize.
- 24. The prizes for the Competition are:
  - a) 5 years and under age category: 2 winners to each receive 1 x \$100 prepaid Visa gift card
  - b) 6 to 12 years age category: 2 winners to each receive 1 x \$100 prepaid Visa gift card
  - c) 13 to 17 years age category: 2 winners to each receive 1 x \$100 prepaid Visa gift card
  - d) 18 years age and over: 2 winners to each receive 1 x \$100 prepaid Visa gift card
- 25. The total prize pool for the Competition is valued at a maximum of \$800.00.
- 26. Prizes are not transferable, exchangeable or redeemable for cash. No compensation will be payable if a winner is unable to use the prize in this form or if the prize expires.
- 27. Following the draw, the Proponent will communicate with each winner to arrange for either:
  - a) the winners to collect their prize in person from the Proponent during business hours (on a date to be mutually agreed between the winner and the Proponent) but in any event on or before Friday 9 June 2023 or
  - b) the Proponent to post the prize to a winner using the winner's postal address as set out in the winner's entry form.
- 28. Where a winner of a prize is under 18 years of age, their prize will be awarded in the company of their parent or legal guardian.
- 29. The Proponent is not responsible for any lost, misdirected or stollen prizes including any issues associated with the post or postage disruption.
- 30. The Proponent reserves the right to request winners to provide proof of identity to claim a prize. Proof of identification and entry considered suitable for verification is at the discretion of the Proponent. If a winner cannot provide suitable proof, the winner will forfeit the prize in whole and no substitute will be offered.
