Parking a heavy vehicle on private residential land

Manningham Community Local Law 2023

26. Vehicles on residential land

An owner or occupier must not, without a permit, keep or allow to be kept, a vehicle that:

- a. has a gross vehicle mass of in excess of 4.5 tonnes; or
- b. together with any load or projection, measures 7.5 metres or more in length on residential land.

Note: This clause excludes caravans.

The current Local Law regulates the parking of an oversize vehicle on private residential land, however in certain circumstances a Permit will be issued to the owner of the land to permit the parking.

The purpose of the permit assessment is to ensure that the oversize vehicle does not impact on neighbouring properties, public safety or cause damage to Council assets.

Applying for a permit

We will look at a number of factors including those listed below. Applicants should provide as much information as possible.

- Will the parking impact footpaths, pedestrian traffic, vehicular thoroughfare, neighbouring properties or businesses, e.g. noise, air pollution and obstruction.
- What is the period of time that the oversize vehicle will be onsite and its location on the land?
- Does the property owner support the application?

- Does the size, type of vehicle and what it is used for present a risk to the community driving through the streets and the length of travel through those streets?
- Does the vehicle need to reverse into the property, noise impact of reversing beepers and warming the vehicle before use?
- What is the noise and visual impact of the vehicle on the land on neighbours and the street scape? Are items stored in or on the vehicle hazardous?
- Is there likely to be damage to Council assets?
- Will maintenance on the vehicle be performed on the land?

Submit the application form ensuring you have all the information needed

- Payment of fee (non refundable if the permit is not approved).
- Tare, length, registration, make/model of vehicle - enclose a photo with a site plan.
- Duration, arrival and departure times and any other documentation to support your application.
- Residents affected by the application will have the opportunity to provide comment.
