

Terms and Conditions of Entry

1. The “A Day with your Faves” Campaign 2023/4 (**Competition**) is run and managed by Manningham City Council, 699 Doncaster Road Doncaster Victoria 3108 (**Proponent**).
2. Entry into the Competition is deemed as acceptance of these Terms and Conditions of Entry.
3. Failure by the Proponent to enforce any of its rights under these Terms and Conditions of Entry at any stage, does not constitute a waiver of those rights.
4. The Proponent may disqualify any entrant deemed not complying with the Terms and Conditions of Entry and the Entry Requirements at its sole discretion.
5. Entry to the Competition is achieved by submitting either an image or a short video taken of a Manningham based business, place, or event either:
 - a. by following and tagging @findyourlocalmanningham in the post on the entrants own public Instagram page, or
 - b. by submitting a nomination via the entry form at www.manningham.vic.gov.au/findyourlocal in accordance with the Entry Requirements.
6. Only submissions of businesses, places or events located within the Manningham Local Government Area will be accepted and valid for competition entry. See maps available on <https://www.manningham.vic.gov.au/about-council/discover-our-area-history-and-demographics/maps>
7. Entries:
 - a. must not depict persons under the age of 18 without the written consent of that person's legal guardian;
 - b. must not contain explicit images of any kind, weapons or any material contrary to the Proponent's policies or of an objectional nature as determined by the Proponent in its absolute discretion; and
 - c. if deemed inappropriate for any reason, will be removed, untagged and/or deleted by the Proponent in its absolute discretion from the Proponent's social media pages.
8. Participants must ensure that they have received the consent of any persons depicted in their entry to share that image prior to submitting their entry.
9. By entering and participating in the Competition, the entrant agrees to release Instagram and Council from and against any and all claims, demands, liability, damages or causes of action (however named or described), losses, costs or expenses, with respect to or arising out of or

PROMOTIONAL PERIOD

12. Entries must be submitted to the Competition during the campaign period from 12.01am on Monday 30 October 2023 to 11.59pm on Friday 2 February 2024, after this date no further entries to the Competition will be permitted.

WHO CAN ENTER

13. Entry to the Competition is open to Victorian residents aged 18 years and over.
14. Manningham City Council staff, contractors and Councillors are not eligible for entry to the Competition (however may participate in the campaign to help support and promote the Competition and its objectives).
15. Entry to the Competition is free.

ENTRY REQUIREMENTS

16. Entry to the Competition is achieved by an eligible entrant submitting either an eligible image or an eligible short video about a Manningham based business, place or event either:
 - a. by tagging @findyourlocalmanningham in the post on the entrants own public Instagram page, or
 - b. by submitting a nomination via the entry form at www.manningham.vic.gov.au/findyourlocal
17. For an Instagram entry to be eligible to enter the competition the entrant must follow @findyourlocalmanningham
18. For an Instagram entry to be eligible to enter the competition, the location of the Manningham based business, place or event must be identified in the post.
19. For an Instagram entry to be eligible to enter the competition, the privacy settings of the entrants Instagram account must be set to 'public'.
20. For entries via the Manningham website, all fields of the online form must be completed - including the entrant's contact details and name and location of a Manningham based business, place or event - for the entry to be valid.

21. Entries where an entrant submits multiple images of the same business, place or event, will only count as one entry into the Competition.
22. There is no limit to the number of entries per person submitted during the Competition period.
23. Entries will be reviewed by a Council Officer for compliance with the Entry Requirements.
24. Entries deemed by the Proponent, in its sole discretion, to be in breach of the Terms and Conditions of Entry or the Entry Requirements, will be disqualified from the Competition without further notice.

WINNER DETERMINATION & PRIZE INFORMATION

25. Each photo or video of a different business, place or event will represent one entry into the Competition.
26. The prize pool comprises of a total of three (3) Find Your Local EFTPOS gift cards valued at \$500 each (1 gift card per winner and a total of 3 winners).
27. The total prize pool for the Competition is \$1,500.
28. The Proponent will randomly select a total of three (3) winners from the eligible submissions received and announce them on the Find Your Local Instagram page on Thursday 8 February 2024.
29. Winners will also be contacted via Direct Message (Instagram entries) or emailed (webform entries) on Thursday 8th February 2024 to arrange collection of their gift card.
30. Each of the 3 randomly selected winners will receive one (1) \$500 Find Your Local EFTPOS gift card.
31. If the winners fail to respond to notification that they have won the Competition within 72 hours of the notification being sent by the Proponent, a second draw will be conducted to determine a new winner as soon as practicable. The Proponent's selection is final and no correspondence will be entered into once the final selection has been made.
32. Gift cards can be posted to winners at the entrants own risk, or will be available for collection from the Manningham Civic Centre at 699 Doncaster Road, Doncaster within 14 days of being notified that they have won the competition. Winners should visit www.manningham.vic.gov.au to see the Civic Centre opening hours.
