
This book helps you understand what to do if you get a **rates notice**.





Rates means money you must pay to council if you own a home in Manningham.

A rates notice is a bill.



This book tells you

- how to read your rates notice
- how to pay your rates.





You get many services when you live in Manningham Council.



Rates help us pay for these services.











In 2023 your rates help us pay for

- waste and recycling
- roads and street lights
- community buildings
- libraries and art programs
- parks and sport fields.







Your rates also help us support

- people with disability
- older people
- children and families.



We use your rates to make Manningham a better place to live.



For example we use your rates to

• look after the environment



• keep people safe.



When you pay your rates, you also pay for the firefighters in your area.

#### About your rates

Every home owner pays different rates.




How much you pay depends on the **value** of your home.



Value means how much money you could get for your home if you sell it.

The state government works out each year


- the value of your home
- the value of other homes in your area.



We check the home values each year.

We then work out rates for everyone.






If your home has a big value you pay more rates.

If your home has a small value you pay less rates.



The rates change every year.



Next year your rates might be

• higher

or



• lower.




You can pay your rates in many small amounts.

#### How to read your rates notice



The rates notice shows at the top how much money you **must** pay.



The rates notice also shows the **due date**.

Due date means when you **must** pay by.



The rates notice shows what we do with your rates.



At the bottom the rates notice shows the total money you **must** pay each year.



## What do the hard words mean?

Your rates notice has many hard words.

The hard words tell you more about your home.



**Site value** means the price you could get for the land without the home.




**Capital improved value** means the price you could get for your home and your land together.



**Net annual value** means a yearly price that your home could be rented out for.



Level of value date is when the state government worked out the value of your home.



Valuation effective date means the day we made your rates.

### How often do you need to pay?

You can choose how often you want to pay your rates.


We normally send you a bill every 3 months.

This means you will pay 4 small amounts of money each year.


You can also choose to pay a smaller amount almost every month.


You can only choose how often you pay if you start direct debit.


Direct debit means you tell us we can take money from your bank account when your rates are due.











You can go to our website to start direct debit.

- a financial counsellor.




A financial counsellor can help you understand your money.

## What if you do not have much money to pay?



We may lower your rates if you have a **concession** card from the government.



Concession means you pay less.



You need to tell us your **property ID** when you pay your rates.

Your property ID is a number at the top of your rates notice.

There are many ways to pay.



#### By credit card

You can pay online on our website.

#### By BPay

BPay means you pay online at your bank using the code on your rates notice.

#### By direct debit



You can fill in a form on our website to start direct debit.

You can tell us how many **instalments** you want to pay each year.



Instalments means small amounts of money.


You can pay at our customer service centre.


