

# Upcoming day works for North East Link

## Property dismantling works on Ilma Court, Bulleen

### What we'll be doing

We will be dismantling two vacant properties and removing materials from site.

This will involve:

- Securing the site with temporary fencing
- Implementing environmental controls including dust suppression
- Using controlled methods to dismantle structures and fences
- Removing vegetation under the supervision of independent arborists and wildlife handlers
- Preparing materials for transport to disposal facilities.

### Where and when we'll be working

We will be working at 1 and 18 Ilma Court, Bulleen from **Monday 16 August** for up to **eight weeks**.

Working hours are **7am to 6pm** on weekdays, and **7am to 1pm** on Saturdays.

**Please note dates and times are subject to change.**

### What this means for you

We will contact properties near work areas in advance to provide further information about planned disruptions.

During these works you may notice:

- Work crews and construction vehicles
- Construction vehicles using Ilma Court via Bulleen Road to access work areas
- Noise from machinery and equipment
- Traffic management equipment, signage and personnel
- Restricted driveway access and on-street vehicle parking near work areas.

### Managing safety during property dismantling works

You may notice workers on site wearing additional personal protective equipment as part of dismantling works. These are specialised hygienists trained to safely handle any hazardous materials that may be present. We engage hygienists as a precautionary measure to protect workers, the community, wildlife, and the environment.

Hazardous materials identified on our work sites are carefully managed in line with the project's strict Environmental Performance Requirements and the relevant legislation. This includes safe disposal according to Environment Protection Authority (EPA) requirements.


Our community engagement team will be available to assist residents during the works. Safety is our priority and we ask for your assistance by following all instructions and signage.

## Health and safety

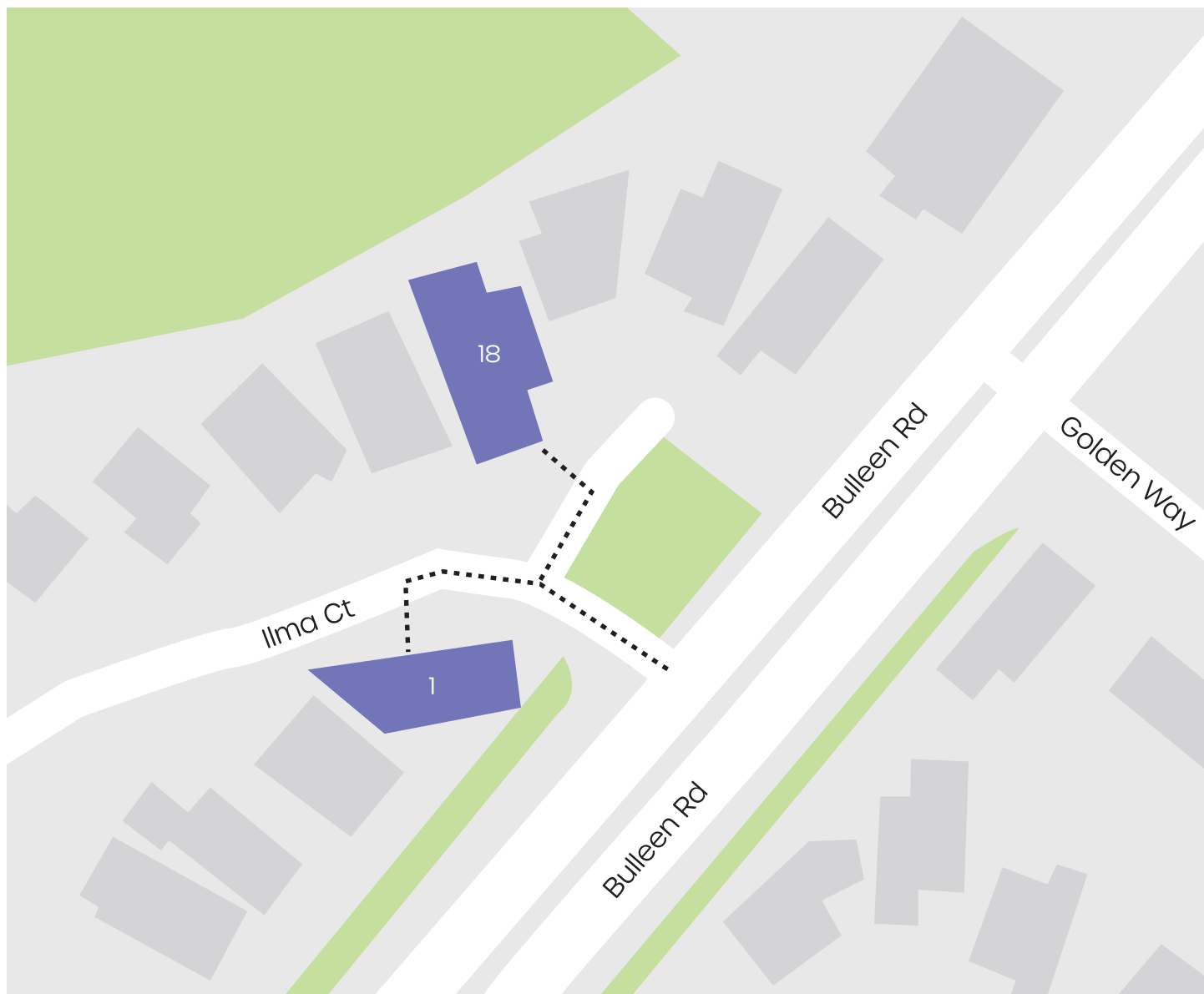
